Amateur Adult & Minor Athletic Waiver & Release Of Liability

In consideration of being allowed to participate in any way in *Highline Arena* athletics/sports program and related events and activities, the undersigned:

1. Agrees that the participant &/or legal guardian of participant that is under 18 years of age should inspect the facilities and equipment to be used and if the participant believes anything is unsafe, he or she should immediately advise his or her coach or supervisor of such condition(s) and refuse to participate.
2. Acknowledge and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence but the action, inaction or negligence of others, the rules of play, or the condition of the premises or any equipment used. Further, that there may be other risk not known to us or not reasonably foreseeable at this time.
3. Assumes all the foregoing risks and accepts personal responsibility for the damages following such injury, permanent total disability, or death.
4. Releases, waives, discharges and covenants not to sue *Highline Arena*, its affiliated clubs, their respective administrators, directors, agents, coaches, and other employees of the organization; other participants, sponsoring agencies, advertisers, and if applicable, owners and leasers or premises used to conduct the event, all of which are hereinafter referred to as "releases" from any liability to each of the undersigned, his or her heirs and next of kin for any and all claims, property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.
